GENERAL INFORMATION

AIR TRANSPORTATION from New York and return by Olympic Airways or other scheduled carriers. The airfare included in the tour price is the lowest applicable fare at the time of printing, December 2004 and is subject to change without notice. Airfare is non-refundable once tickets are issued.

ACCOMMODATIONS are in First Class (4 & 5 star) hotels, in twin-bedded rooms with private facilities. You will receive a detailed list of all the accommodations on your tour, including addresses and telephone numbers, with your travel documents.

MEALS are buffet breakfast, lunch and dinner daily in Turkey and buffet breakfast and dinner daily in Greece. Beverages are not included except coffee and tea with meals.

TRANSFERS & TOURING are provided by modern, air-conditioned coaches. All entrance fees to places visited in the itinerary are included except those mentioned as optional.

TOUR PRICE is based on a group of 20 or more passengers. Should the group number fall below 20, the tour price will increase slightly to accommodate the smaller group size. Our tour includes flights from New York, airport departure taxes, hotel accommodations, meals as indicated, touring per itinerary including entrance fees, teaching fee, study materials, hotel taxes, portage. and personal tips to your guide, driver and hotel dining room staff. Our rates do not include passports or any items of a personal nature. All prices are based on air and land tariffs in effect at time of printing, October 2004, subject to change by our suppliers without notice.

DEPOSIT of \$400 per person is required when placing reservations. Deposits can be paid by check or credit card. Prices shown reflect cash discount of 4% for payments by check only. Final Payments are due at 75 days prior to departure.

UNUSED SERVICES As all tours are based on group travel, no refunds will be granted for missed sightseeing trips, meals, transfers or hotel accommodations not used.
