AIR TRANSPORTATION from USA and return by EgyptAir or other scheduled carriers. The airfare included in the tour price is the lowest applicable fare at the time of printing, July 2006, and is subject to change without notice. Airfare is non-refundable once tickets are issued.

ACCOMMODATIONS are in deluxe hotels & riverboats, in twin-bedded rooms/cabins with private facilities. You will receive a detailed list of all the accommodations on your tour, including addresses and telephone numbers, with your travel documents.

MEALS are buffet breakfast, lunch and dinner daily. Beverages are not included except coffee and tea with meals.
