GENERAL INFORMATION

AIR TRANSPORTATION from USA and return by Lufthansa or other scheduled carriers. The airfare included in the tour price is the lowest applicable fare at the time of printing, August 2005, and is subject to change without notice. Airfare is non-refundable once tickets are issued.

ACCOMMODATIONS are in deluxe hotels & riverboats, in twin-bedded rooms/cabins with private facilities. You will receive a detailed list of all the accommodations on your tour, including addresses and telephone numbers, with your travel documents.

MEALS are buffet breakfast, lunch and dinner daily. Beverages are not included except coffee and tea with meals.

TRANSFERS & TOURING are provided by modern, air-conditioned coaches. All entrance fees to places visited in the itinerary are included except those mentioned as optional.

TOUR PRICE is based on a group of 21 or more passengers. Should the group number fall below 21, a small supplement to the tour price will apply. Our tour includes flights from Minneapolis, hotel & cruise accommodations, meals as indicated, touring per itinerary including entrance fees, hotel taxes and portage. Our rates do not include passports or any items of a personal nature. All prices are based on air and land tariffs in effect at time of printing, August 2005, subject to change by our suppliers without notice.

DEPOSIT of \$300 per person is required when placing reservations. Deposits must be made by check and are due by no later than 9/30/05. Final payment is due by 11/1/05 and may be made by credit card. Prices shown reflect cash discount of 4% for payments by check only.

UNUSED SERVICES As all tours are based on group travel, no refunds will be granted for missed sightseeing trips, meals, transfers or hotel accommodations not used. No changes in hotels, deviations or extensions in the itinerary are allowed on this tour unless arranged prior to departure from the U.S.A.

CANCELLATIONS of reservations must be made in writing. Refund in full will be made up to 95 days prior to departure, excluding a \$25 per person administrative fee and the \$99 insurance premium. Cancellations within 94 days prior to departure are subject to the following charges:
