#### **GENERAL INFORMATION**

**AIR TRANSPORTATION** from Los Angeles and return by Air Canada or other scheduled carriers. The airfare included in the tour price is the lowest applicable fare at the time of printing, January 2005 and is subject to change without notice. Airfare is non-refundable once tickets are issued.

**ACCOMMODATIONS** are in superior class hotels, in twin-bedded rooms with private facilities. You will receive a detailed list of all the accommodations on your tour, including addresses and telephone numbers, with your travel documents.

MEALS are breakfast and dinner daily. Beverages are not included except coffee and tea with breakfast and dinner.

**TRANSFERS & TOURING** are provided by modern, air-conditioned touring coaches. All entrance fees to places visited in the itinerary are included.

**TOUR PRICE** is based on a group of 25 or more passengers and includes flights from Los Angeles, hotel accommodations, meals as indicated, touring per itinerary including entrance fees, hotel taxes, and porterage.
