## GENERAL INFORMATION

**AIR TRANSPORTATION** from US gateways via United/Lufthansa/Austrian or other scheduled carriers. The airfare included in the tour price is the lowest applicable fare at the time of printing, October 2010 and is subject to change without notice. Airfare is non-refundable once tickets are issued.

**ACCOMMODATIONS** are in first class & superior hotels with private facilities. You will receive a detailed list of all the accommodations on your tour, including addresses and telephone numbers, with your travel documents. Single occupancy rooms are at a supplement in cost.

**MEALS** are buffet breakfast and dinner daily. Beverages are not included except coffee and tea with breakfast and dinner.

**TRANSFERS** are provided by modern, air-conditioned touring coaches.

**TOUR PRICE** includes flights from New York, Buffalo and Pittsburgh, airport departure taxes, fuel surcharges, hotel accommodations, meals as indicated, transfers per itinerary, hotel taxes and portage of one checked suitcase per person. Our rates do not include personal tips, passports, or any items of a personal nature. All prices are based on air and land tariffs in effect at time of printing, October 2010, subject to change by our suppliers without notice. Taxes and fuel surcharges are based on tariff in effect and subject to change by the airlines until tickets are issued.

**DEPOSITS & PAYMENTS** A deposit of \$300 per person is required when placing reservations. Deposits are refundable in full, less a \$50 administrative fee, at 90 days or more prior to departure. Final payments are due at 75 days prior to departure (Jan. 3, 2011). Reservations received after this date will be on a request basis and must be accompanied by payment in full. Prices are based on payment of services by check only.

**UNUSED SERVICES** As all tours are based on group travel, no refunds will be granted for missed sightseeing trips, meals, transfers or hotel accommodations not used. No changes in hotels, deviations or extensions in the itinerary are allowed on this tour unless arranged prior to departure from the U.S.A.
