GENERAL INFORMATION

AIR TRANSPORTATION from Austin and return via Delta Airlines or other scheduled carriers. The airfare included in the tour price is the lowest applicable fare at the time of printing, April 2006, and is subject to change without notice.

ACCOMMODATIONS are in First Class & Superior hotels, in twin-bedded rooms with private facilities. You will receive a detailed list of all the accommodations on your tour, including addresses and telephone numbers, with your travel documents.

MEALS are buffet breakfast and dinner daily plus 2 lunches. Beverages are not included except coffee and tea with breakfast.

TRANSFERS & TOURING are provided by modern, air-conditioned motor coaches. All entrance fees to places visited in the itinerary are included.

TOUR PRICE is based on a group of 25 or more passengers and includes flights from Austin, airport departure taxes, fuel surcharges and airport fees, accommodations in twin-bedded rooms, meals, personal tips and touring as indicated in our itinerary. Prices do not include passports or items of a personal nature. Prices are based on air and land tariffs in effect at time of printing, April 2006, subject to change by our suppliers without notice.

DEPOSIT of \$300 per person is required when placing reservations. Deposits for this tour are due by 120 days prior to departure (by July 14, 2006). Final payment is due by 75 days prior to departure (by September 1, 2006).

CANCELLATIONS of reservations must be made in writing. Refund in full will be made up to 125 days prior to departure, excluding a \$50 per person administrative fee and the insurance premium cost of \$129. Cancellations within 95 days prior to departure are subject to the following charges:
