AIR TRANSPORTATION from USA and return by EgyptAir or other scheduled carriers. The airfare included in the tour price is the lowest applicable fare at the time of printing, April 2007, and is subject to change without notice. Airfare is non-refundable once tickets are issued.

ACCOMMODATIONS are in deluxe hotels & riverboats, in twin-bedded rooms/cabins with private facilities. You will receive a detailed list of all the accommodations on your tour, including addresses and telephone numbers, with your travel documents.

MEALS are buffet breakfast, lunch and dinner daily. Beverages are not included except coffee and tea with meals.

TRANSFERS & TOURING are provided by modern, air-conditioned coaches. All entrance fees to places visited in the itinerary are included except those mentioned as optional.

TOUR PRICE is based on a group of 21 or more passengers. Should the group number fall below 21, a small supplement to the tour price will apply.
