## GENERAL INFORMATION

**AIR TRANSPORTATION** from Minneapolis and San Francisco via EL AL ISRAEL AIRLINES or other scheduled carriers. The airfare included in the tour price is the lowest applicable fare at the time of printing, May 2010 and is subject to change without notice. Airfare is non-refundable once tickets are issued.

**ACCOMMODATIONS** are in superior class hotels with private facilities. You will receive a detailed list of all the accommodations on your tour, including addresses and telephone numbers, with your travel documents. Single occupancy rooms are at a supplement in cost.

**MEALS** are buffet breakfast and dinner daily. Beverages are not included except coffee and tea with breakfast and dinner.

**TRANSFERS** are provided by modern, air-conditioned touring coaches.

**TOUR PRICE** includes flights from Minneapolis or San Francisco, fuel surcharges, hotel accommodations, meals as indicated, transfers per itinerary, hotel taxes, and portage of one checked suitcase per person. Our rates do not include tips, airport taxes, fees & September 11 Security Fee, passports, or any items of a personal nature. Our advertised prices do not include U.S. and foreign government taxes and fees of up to \$240, depending upon the tour, including the September 11th Security Fee of \$2.50 per U.S. enplanement, up to \$10 round trip, the International Arrival Tax of \$15.40, the International Departure Tax of \$15.40, the Immigration User Fee of \$7, the Customs User Fee of \$5.50, the APHIS User Fee of \$5, and passenger facility charges (PFCs) imposed by the airports, of up to \$18 round trip. All prices are based on air and land tariffs in effect at time of printing, May, 2010 subject to change by our suppliers without notice. Taxes and fuel surcharges are based on tariff in effect and subject to change by the airlines. Tour price is based on minimum 30 passengers per motor coach. An increase in price will apply if minimum number of passengers is not met.

**DEPOSITS & PAYMENTS** A deposit of \$300 per person is required when placing reservations. Deposits may be paid by credit card or check. Deposits are refundable in full, less a \$50 administrative fee, at 121 days or more prior to departure. Deposit is non-refundable at 120 days prior to departure. Final payments are due at 75 days prior to departure (**October 08 2010**). Reservations received after this date will be on a request basis and must be accompanied by payment in full. Final payments which are paid by credit card are subject to a service fee of 3% of the balance due. (No service fee is charged for deposits or insurance paid by credit card.)

**UNUSED SERVICES** As all tours are based on group travel, no refunds will be granted for missed sightseeing trips, meals, transfers or hotel accommodations not used. No changes in hotels, deviations or extensions in the itinerary are allowed on this tour unless arranged prior to departure from the U.S.A.
